I am aware that travel to the foreign countries and/or remote areas visited by this trip involves numerous risks and dangers including, but not limited to: the forces of nature; roads, trails, hotels, vehicles, boats or other means of conveyance which are not operated or maintained to standards common in the United States; civil unrest, terrorism; war; the hazards of traveling through mountainous terrain, at high altitudes, or to undeveloped areas; travel by canoe, boat, bicycle, train, plane, automobile, horseback, or by other means of conveyance, or by foot; accident or illness without access to means of rapid evacuation or availability of medical supplies; the adequacy of medical attention if provided; physical exertion to which I am unaccustomed or for which I am not prepared; consumption of alcoholic beverages; or additional factors known or unknown. Cancellations and Refunds: All cancellations must be submitted in writing to Limitless Argentina, Inc. Written cancellations up to 90 days prior to departure will receive a full refund minus a \$200 per person administrative fee and any direct airline ticketing costs that were incurred on behalf of the customer before receipt of the written cancellation. Written cancellations received within 90 days of departure could result in the forfeiture of the full program price, contingent upon the degree of recoverable costs from the individual purveyors of services. We strongly urge applicants to consider purchasing trip cancellation insurance. There are no refunds or cancellations as of 45 days prior to the departure of the trip.

Limitless Argentina reserves the right to cancel any trip at any time for any reason if there are too few participants, or if the quality of the trip or the safety of travelers is judged to be compromised. In such a case, refund of payments received by Limitless Argentina shall constitute full settlement. Limitless Argentina cannot assume responsibility for any loss incurred on account of non-refundable air tickets. Service fees may apply to deviations and are non-refundable.

General Information

Insurance: Before traveling on a trip, Limitless Argentina strongly recommends that you review your personal insurance and your health insurance to ensure you have coverage appropriate to meet your needs, and the needs of your family and dependents, in case of any loss of property, or accident, injury or death. We also strongly recommend the purchase of trip cancellation insurance, which is available for coverage of expenses in conjunction with cancellation due to illness or accident. Baggage insurance is also recommended. In the event that you must cancel your participation in the trip, trip cancellation insurance may be the only source of reimbursement.

Itinerary: The itinerary, accommodations and arrangements are subject to change.

Responsibility

Preparing for your trip

Our trips entail risks – and rewards – beyond those encountered at home. We always stress that our trips are a partnership with travelers. Our primary objective is to take the hassle out of a great travel experience. In return, we count on people to ensure they are healthy and fit and to read our pre-trip materials.

Travel Documents and Passport

The Visa and Passport requirements of countries to which we travel vary by nationality and change for reasons beyond our control. Although we endeavor to provide you with accurate information about these requirements it remains the responsibility of each traveler to verify that they have the appropriate travel documents. Limitless Argentina cannot be liable for any expenses or costs arising from a traveler being prohibited from entering a country.

External Travel Services

Limitless Argentina may recommend the services of external travel agencies or other support services in response to requests made by travelers for services outside of the scope of the Limitless Argentina trip. Although we endeavor to recommend only companies that provide the highest levels of service and work closely with them to obtain special treatment for Limitless Argentina travelers, we cannot guarantee the services provided by these third party service providers. Limitless Argentina cannot be liable for any expenses arising from any services provided by any external travel service company.

Delays

Airplane, bus, train and transfer delays are quite normal when traveling in the Southern Cone of South America. These delays can impact your ability to fulfill the specific itinerary developed by Limitless Argentina or extra activities you plan on your own. In addition, these delays may cause you to miss complete legs of your trip or incur extra housing costs. While Limitless Argentina will strive to resolve these situations promptly, we cannot be held liable for the ramifications of missed, delayed or canceled flights, transfers, buses or trains.

In addition, delays or cancellations with international travel at the beginning or end of your Limitless Argentina trip are common. Limitless Argentina cannot be held liable for any extra costs incurred by these incidents or any missed activities, excursions or destinations due to events that take place before your trip with Limitless Argentina commences or terminates.

Health

By sending a payment toward your trip purchase, you certify that you do not have any physical condition or disability that would create a hazard for you or other travelers and you have received all appropriate immunizations. Please consult your doctor.

Risks

All Limitless Argentina Inc. trips may bring clients to places where facilities, infrastructure, and safety standards may be different from those in a traveler's home country. Some trips involve physical activity that can be demanding, as requested by the traveler, and the risk of serious personal injury, including permanent disability and death from accident, illness or the actions or negligence of other persons. Medical facilities and services may not be easily accessible and may not be sophisticated. There are other risks associated with the trips, such as theft or loss of or damage to property.

Limitation of Liability, Release and Indemnity

To be eligible to take a Limitless Argentina trip, travelers must accept these risks and assume full responsibility for any loss, injury, death or damage to them, their family or their dependants arising in connection with their participation, or the participation of their family, in the trips. Travelers must have their own insurance appropriate to their needs and the needs of their family or dependents in respect to such loss, injury, death or damage.

Although Limitless Argentina endeavors to choose appropriate independent suppliers to provide services on the trips, Limitless Argentina has no right to control their operations and therefore makes travel arrangements for the trips on the condition that Limitless Argentina will not be liable for any act or omission of any independent supplier or any unrelated third party. The services provided by independent suppliers are subject to the laws of the place where the services are provided, and any conditions imposed by those suppliers. The liability of the independent suppliers may be limited by their tariffs, conditions of carriage, tickets and vouchers, and international conventions and agreements.

The cost of all Limitless Argentina trips is based on travelers agreeing to this Limitation of Liability, Release and Indemnity. In consideration for participating in the trips, travelers agree not to sue Limitless Argentina in respect of, and forever release them from, all liability for economic loss and physical or mental injury, direct or indirect, arising in connection with the trip – including, without limitation, permanent disability and death; any emotional distress; any loss of services, financial support, aid, consortium or companionship; and any damage to or loss of property – in each case even if caused in whole or in part by the conduct, including the negligence, of Limitless Argentina, except where such loss, injury or damage is caused by reckless or fraudulent conduct on the part of Limitless Argentina or its employees, shareholders, officers or directors, in which case the traveler retains the right to sue only Limitless Argentina in respect of that conduct.

Travelers further agree that they will defend, indemnify and hold Limitless Argentina harmless in respect of any claims arising in connection with the trip made by: i) third parties, which arise from the negligence or misconduct of the travelers; ii) the traveler's family members, dependents or heirs, iii) third parties, which the traveler, their estate, their family members, dependents or heirs have sued, if damages are recovered from such third parties, to the extent the third party obtains any indemnification from Limitless Argentina, except where the loss, injury, death or damage is caused by the reckless or fraudulent conduct on the part of Limitless Argentina, or its employees, shareholders, officers or directors. In the unlikely event a legal dispute should arise involving any subject matter whatsoever, I agree that the maximum amount of recovery to which I will be entitled under any and all circumstances will be the land cost of my trip with Limitless Argentina.

Limitless Argentina reserves the right to decline accepting or retaining any traveler whose health or actions in Limitless Argentina's sole judgment impede the operation of a trip or the welfare or enjoyment of fellow travelers. In further consideration for participating in the trip, travelers agree that Limitless Argentina, or its designees, may use any photographic or film records of the trips for promotional and/or commercial purposes, without any remuneration to the traveler. The traveler agrees to assign all right, title and interest they may have in or to any media in which their name or likeness might be used to Limitless Argentina.

This Limitation of Liability, Release and Indemnity is binding upon all members of the traveler's family, dependents, estate, heirs, successors and legal personal representatives. Any claim or dispute arising out of or relating to this Limitation of Liability, Release and Indemnity or its interpretation, the trip, or the traveler's relationship with Limitless Argentina will be resolved exclusively in the courts of Argentina and will be governed exclusively by Argentine law.

I further acknowledge that payment to Limitless Argentina represents an acceptance of these conditions and those in Limitless Argentina's Terms & Conditions and Payment Policy and Cancellation Terms, in which I have noted Limitless Argentina's cancellation & refund policies, and agree to all stated conditions set forth there within. I am aware that this is a release of liability and a contract between myself and Limitless Argentina, Inc. and sign it of my own free will.
